- 4. If it becomes necessary to utilize the services of an attorney to enforce any provision of this contract the prevailing party shall be entitled to recover attorney and/or court fees and costs.
- 5. I understand that in signing this Enrollment Contract for the coming academic year, I am agreeing to accept the rules and regulations of the School as stated in the current Handbook for Parents/Student's and the rule concerning payment of fees as referred to above for the coming academic year.
