WHEREAS, Nativity School operates a parochial elementary/middle school and,  
WHEREAS, the undersigned parents desire their child to be enrolled in said school,  
NOW THEREFORE, with the intent to be legally bound hereby, the parties agree as follows:

1. The school will accept \_\_\_\_\_ as a student(s) for the 2025 - 2026 school year, subject to the school's rules and regulations regarding behavior and academic matters.
2. In consideration of the acceptance of this Contract by Nativity School, the undersigned agrees to pay the required fees as specified in the Nativity School Tuition and Fees 2025 - 2026 schedule (copy attached). I understand that my obligation to pay the fees for the full academic year is unconditional and that after **June 1, 2025**, no portion of such fees paid or outstanding will be refunded or cancelled in the event of absence or withdrawal from the School of the above student(s). It is further agreed that enrollment, as specified within this Enrollment Contract, may be cancelled by the parents or guardians in writing, without penalty prior to **June 1, 2025**. Letter notification must be hand delivered or postmarked prior to **June 1, 2025**. If enrollment is cancelled after **June 1, 2025**, parents or guardians financially responsible for the student(s) are obligated to pay the full annual fees and tuition.
3. Furthermore, I agree to the policy of the School that no student will be permitted to take examinations nor will grades and/or transcripts be released unless such student's tuition account is current. I also understand that the School reserves, and has the right, to deny admission of the student(s) to classes should fees not have been paid by the required date. I acknowledge that accounts 30 days or more past due are subject to a service charge of \$25.00 per month.
4. If it becomes necessary to utilize the services of an attorney to enforce any provision of this contract the prevailing party shall be entitled to recover attorney and/or court fees and costs.
5. I understand that in signing this Enrollment Contract for the coming academic year, I am agreeing to accept the rules and regulations of the School as stated in the current Handbook for Parents/Student's and the rule concerning payment of fees as referred to above for the coming academic year.
6. As further consideration, the parents/guardians agree to acquaint themselves with the requirements of the Handbook for Parents/Students. A contribution of volunteer time to the school and participation in the PTO sponsored Fundraising events is required. The Nativity School PTO may also conduct periodic FUN-raising events (focused on FUN!) and your participation in these events is highly valued and appreciated. Additionally, your contribution to the Nativity School Annual Fund Drive is greatly encouraged and extremely important in helping to support the staff and students of Nativity School.
7. The parents/guardians further agree to participate in parent/teacher conferences and all other matters relating to the child's educational activities.
8. The school agrees to maintain appropriate communication with the parents/guardians.
